6 WHEREAS, The African American Reparations Advisory Committee (AARAC) was  
7 established in Ordinance No. 29-20 to advise the Board of Supervisors, the Mayor, the  
8 Human Rights Commission, and the public regarding the development, adoption, and  
9 implementation of a San Francisco Reparations Plan that determines the scope and eligibility  
10 for citywide reparations program, examines the current and structural discrimination within  
11 San Francisco, and proposed institutional reforms to guard against the need for future  
12 redress; and

13 WHEREAS, The AARAC convened the inaugural meeting in June 2021; and

14 WHEREAS, The full committee and subcommittees have met consistently to collect  
15 data, hear presentations from experts, and receive guidance from the public on what  
16 information to include in the Final San Francisco Reparations Plan; and

17 WHEREAS, The AARAC on July 7, 2023, submitted the Final San Francisco  
18 Reparations Plan of the African American Reparations Advisory Committee; now, therefore,  
19 be it

20 RESOLVED, That the San Francisco Board of Supervisors does hereby accept the  
21 Final San Francisco Reparations Plan of the African American Reparations Advisory  
22 Committee in accordance with Administrative Code, Section 5.46-5.


